1. to take effective steps to ensure the enforcement of traumatized children's rights under the Americans With Disabilities Act in regard to children's participation in legal proceedings.
2. to identify types of trauma which cause toxic stress & identify behaviors that result from trauma.
3. about adverse childhood experiences (ACEs), their short & long-term consequences on physical health, mental health, social health, & how they can be passed from generation to generation.
4. to explain how resilience research is beginning to provide pathways to preventing & reducing effects of adverse childhood experiences.
5. to explain how adverse childhood trauma experiences result in toxic stress that damages children's developing brains, & how this affects their behavior.
6. about how schools integrate trauma-informed practices, including changing teacher behavior, classroom management & school systems.
7. how trauma-informed practices are used for family reunification in Yolo County.
8. how the Yolo County Foster & Kinship Care program implements Trauma-Informed practices.
9. how Trauma-Informed practices reduce recidivism of troubled youth.
